Congratulations on your decision to join JASCO, you have selected one of the country's premiere WWII US Marine Corps re-enactment units. You are about to embark upon a unique and challenging hobby, one which has provided unit members with the opportunity to share their love of history and their appreciation for the WWII veterans whose sacrifices have enabled this country to flourish. We expect our members to have fun and build friendships within the unit and the world of reenacting. Membership in JASCO also includes membership in the 501<sup>st</sup> Parachute Infantry Regiment Reenacting Group.

Attached are the required forms and information necessary to initiate the application process. Understand that not all applications are accepted. We reserve the right to refuse membership to any applicant for any reason. Furthermore, since incomplete or unsigned applications will be returned, please follow the below steps insuring the forms are completed as thoroughly as possible.

1. Complete and sign the application.
2. Complete and sign the Certificate of Disclaimer.
3. Include a copy of a current and valid photo ID (date of birth required).

Your initial \$35.00 fee will cover the following:

1. A set of notched dog tags.
2. A 101<sup>st</sup> Airborne Division shoulder patch
3. Subscription to the unit newsletter.
4. First year membership - \$25 (subsequent dues are \$20 annually).
5. 1 year membership in the LHA Military History Association (LHA-MHA) - \$10

Upon acceptance of your application, you will be assigned as a member of a squad in a platoon comprised of other members in your geographical area. You will be appointed as a trainee until the completion of your 3<sup>rd</sup> event, at which time you will receive a certificate awarding you your Marine cap EGA, and the rank of private first class. Your squad leader will answer any questions and assist you in completing your combat impression. We will assist you in the selection/purchase of uniforms, weapons and field gear by making sure that you get the correct items and usually at a much lower price. This will save you money and disappointment. Until you can afford a complete impression (including weapon, equipment, clothing, etc.), then we will loan you items (that are available) to complete your impression. In addition to unit membership, most event sponsors require membership in a nationally recognized re-enactment organization. Your platoon sergeant can also assist you in the selection of one of these organizations. They will send you a separate membership card. Once again, congratulations on your choice of joining JASCO. Your platoon sergeant will be contacting you soon!
